2. <u>Discussion re: Negotiating Strategy with WTA, WESA, Custodial & Food Service Workers (M.G.L. 30A, sect. 21(a)(3):</u>

WTA: Brad commented that the WTA received the one-year Collective Bargaining Agreement (CBA) that was approved by the School Committee. He also made the changes as recommended by Barb, including the timeline and the one-time payment of \$36,000.

Ellen sent the final version of the Q & A document derived from comments made at a previous meeting to Gini Tate. She clarified that the Q & A only pertains to the WTA and not the other unions.

Once the CBA is ready, the School Committee secretary will distribute it via all modes of communication.

WESA: Brad circulated a draft of the proposed one-year MOA. He added that Gini Tate reviewed the MOA and he hopes to have back within a day. The three-year MOA will incorporate the out-year CQLA's and the increase in tuition reimbursement.

Custodial: Brad noted that he received a short communication from Joe Seletnik, representing the custodial union, and then noted that they hadn't spoken with him in 6 weeks. Joe Seletnik as Brad if the School Committee had changed their mind about researching outsourcing. Brad informed nim that outsourcing would be researched Brad will forward to him proposed meeting dates.
