1. Executive Session:

Subsequent to a roll call vote in Regular Session on a motion brought by Barb Fletcher, seconded by Malcolm Astley, to enter Executive Session at 10:50 p.m. for the purposes of discussing strategy with respect to litigation from the Attorney General's decision regarding the Open Meeting Law Complaints filed by George Harris on June 27, 2013 and Donna Bouchard on July 1, 2013 related to the June 3, 2013 Executive Session, as permitted by M.G.L. Chapter 30A, §21(a)(3), to discuss a public records request related to a corresponding document for the June 3, 2013 Executive Session minutes used in negotiations, as permitted by M.G.L. Chapter 30A, §21(a)(3), to discuss strategy with respect to collective bargaining with the Food Service Workers, as permitted by M.G.L. Chapter 30A, §21(a)(3), and to conduct negotiating strategy session in preparation for contract negotiations with newly appointed business administrator, as ermitted by M.G.L. Chapter 30A, §21(a)(2), as such discussions in open meeting may have a detrimental effect on the digation and collective bargaining positions of the School Committee and an Executive Session is necessary to protect the litigation and collective bargaining positions of the School Committee. In addition, the School Committee will approve minutes from prior executive sessions, as permitted by M.G.L. Chapter 30A, §22, for May 12, 2014.

The School Committee will be joined by Paul Stein, Superintendent of Schools, Brad Crozier, Assistant Superintendent of Schools, and Geoff MacDonald, Business Administrator.

3. Discuss Strategy with respect to Litigation from the Attorney General's Decision re: Open Meeting Law Symplaints Filed by George Harris on June 27, 2013 and Donna Bouchard on July 1, 2013 regarding the June 3, 2013 Executive Session, pursuant to M.G.L. 30A, §21(a)(3):

Ellen updated the School Committee that on June 26th there will be pre-hearing conference between Gini Tate, Mark Higgins and a judge. Ellen explained that this conference is a formal proceeding under Massachusetts law, and it is to determine administrative concerns, such as when the hearing will be held. Gini Tate agreed that Mark Lanza could come up with a resolution to this matter. The School Committee should not admit intent. Ellen will also ask if Wayland residents can attend the hearing.

The School Committee also discussed if Mark Lanza could ask Mark Higgins to negotiate a lesser fine prior to the scheduled hearing. It was agreed that the School Committee would set parameters and authorize Mark to move forward.

Upon a motion duly made by Ellen Grieco, seconded by Malcolm Astley, the School Committee voted (3-1) (Donna voted no based on the violation) to authorize Mark Lanza to negotiate on the School Committee's behalf with the Attorney General's office a settlement with the lowest cost possible and not admitting intentional violation. The Committee also discussed sick time and vacation time, which is in line with the WTA contract.
