Executive Session:

Subsequent to a roll call vote in Regular Session on a motion brought by Ellen Grieco, seconded by Barb Fletcher, the School Committee voted (4-1) to enter Executive Session at 9:48 p.m. for the purposes of discussing strategy with respect to litigation from the Attorney General's decision regarding Open Meeting Law complaints filed by George Harris on June 27, 2013 and Donna Bouchard on July 1, 2013 regarding the June 3, 2013 Executive Session, pursuant to M.G.L. c. 30A §21(a)(3) and to receive an update and discuss strategy with respect to pending litigation between John S. Ames IV and the Wayland Public School System, as permitted by M.G.L. c. 30A §21(a)(3), as such discussion in open meeting may have a detrimental effect on the litigation position of the School Committee and an Executive Session is necessary to protect the litigation position of the School Committee. The School Committee will also discuss the investigation of charges of criminal misconduct, as permitted by M.G.L. c. 30A §21(a)(5), to discuss strategy with respect to an Open meeting Law Complaint filed by George Harris on August 27, 2014 related to certain Executive Session meetings, as permitted by M.G.L. c. 30A, §21(a)(1), will review minutes from the December 2, 2013 executive session for declassification related to a Public Records Request submitted by George Harris on August 27, 2014, as permitted by M.G.L. c. 30A, §22. In addition, the School Committee will review minutes from prior executive sessions for declassification, as permitted by M.G.L. c. 30A, §22, for the Executive Session meetings noted on the meeting notice and will approve minutes from prior executive sessions, as permitted by M.G.L. c. 30A, §22 for the July 10, 2014 and July 17, 2014 Executive Session minutes. The School Committee will reconvene in open session to conduct regular matters as noted on the meeting notice. A roll call vote was taken as follows:

The School Committee will be joined by Paul, Superintendent of Schools, Brad Crozier, Assistant Superintendent, Mariene Dodyk, Director of Student Services, and Diane Marobella.

Donna voted "no" because of agenda item 8(a), which she read, and stated that the public has not been adequately informed of the subject matter.

Discuss Strategy regarding the Investigation of Charges of Criminal Misconduct Pursuant to M.G.L. Chapter 30A §21(a)(5);

Ellen informed the School Committee that, although she had written the agenda topic, Mark Lanza advised against it and provided the wording for the agenda topic. Because this criminal investigation is ongoing with three separates

agencies, Mark advised that both the suggestion of criminal charges and the underlying subject matter are suggestions if disclosure. The School Committee discussed options in posting the agenda in terms of the Committee's strategic esponse regarding a criminal investigation. It was also noted that the language used for this agenda has been used several times in the past. The School Committee will revisit its position on this matter at a future meeting.

Another discussion ensued regarding the redaction of several sets of minutes from a public records request related to the METCO matter. At the advice of town counsel, the School Committee has a legal right to keep this investigation confidential, and the Committee can exercise its judgment as a policy matter and in the best interest of the Wayland Public Schools. The Committee questioned its understanding and comfort level with this advice and explanation, but noting that the first amendment is relevant.

Barb suggested that Mark Lanza attend a meeting to understand what our options are and what are the associated risks related to this matter. The Committee will ask Mark Lanza to follow up with the state agencies regarding the status of the investigations and ask him to update the School Committee on September 22nd.

The Committee also discussed how and if they should address moving forward with the investigation of the credit card statements.

Ellen distributed minutes related to discussions regarding the METCO matter. They were marked for redaction and the Committee will review them at its next meeting on September 22nd.
