Executive Session - December 4, 2015

A secutive Session of the Wayland School Committee was held on Friday, December 4, 2015, at 3:36 P.M. in the School Committee Room of the Wayland Town Building.

Subsequent to a roll call vote in Regular Session on a motion made by Ellen Grieco, seconded by Barb Fletcher, the School Committee voted (5-0) to enter Executive Session at 3:36 p.m. for the purposes of discussing strategy with respect to collective bargaining with the Custodians, as permitted by M.G.L. c.30A, §21(a)(3), as such discussion in open meeting may have a detrimental effect on the bargaining position of the School Committee and an Executive Session is necessary to protect the bargaining position of the School Committee, discussing the investigation of criminal charges, as permitted by M.G.L. c.30A, §21(a)(5), discussing strategy with respect to threatened litigation under Title IX anti-retaliation provisions and M.G.L. c.149, §185, by the former Athletic Director against the Wayland Public Schools and the School Committee, pursuant to M.G.L. c. 30A, §21(a)(3), as such discussion in open meeting may have a detrimental effect on the litigation position of the School Committee and an Executive Session is necessary to protect the litigation position of the School Committee, and approving minutes from prior executive sessions, as permitted by M.G.L. c.30A, §22, for the following meetings: November 2, 2015 - #1 and #2. 2 <u>liscuss Strategy with Respect to Collective Bargaining with Custodians, pursuant to M.G.L. c.30A, §21(a)(3):</u>
Brad confirmed that the custodial Memorandum of Agreement is the same one that had been presented to the Board of Selectmen in July 2015. Brad noted the School Committee's discussions during the summer related to the Memorandum of Agreement (MOA), and commented that the custodians ratified the MOA on December 1st.

John left the meeting by remote at 3:40 p.m., as he will rejoin the meeting when the vote to approve the MOA is taken in open session.

3. Enter Executive Session, pursuant to M.G.L. c.30A, §21(a)(5) to Discuss the Investigation of Criminal Charges. The School Committee will be joined by Police Chief Robert Irving and Town Counsel Mark Lanza:

Chief Irving updated the Committee regarding the investigation of criminal charges and added that he has received several emails from residents. The Chief noted that he spoke with the District Attorney about the arrest and the case against the person under investigation. The District Attorney is confident that the proper process was followed when asking for the school property. The Chief gave an account of the timeline in terms of asking for the school property up to June 23, 2015, at which time the person under investigation denied that he had the school property. It was noted that it is standard for these types of cases to be decided as either "continued without a finding" or dismissed.

Ellen left the meeting at 4:22 p.m.; returned at 4:24 p.m.

The Chief's biggest concern is the safety of the person under investigation, the school staff and students, and noted that the appropriate people have been notified of the facts in this case.

In terms of public notification, Chief Irving noted the places to which information is released as a matter of transparency, including a posting on Facebook and a press release. However, he did note that in this case, Facebook probably was not the best communication vehicle to use and the posting was taken down the same day. He also gave an account of what happened after the person under investigation was taken into custody and how it was communicated to the press.

Paul expressed his concern about improving public perception and commented that he would like to make it better for everyone involved.
