 - Tricia discussed a meeting at High School to collaborate on a high school program for BASE employment. Very well received. Students are interested for a variety of reasons. Would be exciting for elementary students. This would be a different program from Leadership in Training. Commitment is key.

3:15 3. Presentation of Revised Draft

- Tricia did some work on the Happy Hollow Handbook. She learned a lot. There was some repetition. Edited out some language that seemed to be in reaction to past incidents. Didn't touch any of the mandated sections. Take a few minutes to look through handbook and give comments.
- Still new ways to approach the material: thought Reporter, Hawk, small skits.
- Need to add the ALICE information for drills; still refining safety measures with police.
 Nan asked what kind of information we share in the handbook? Tricia answered that we
 notify parents ahead of time if we're doing a drill, if we discussed it in class. We
 communicate a lot and well in the moment. Direct line, we practice, communicate,
 process that we've created with the police.
- Prashant asks if we can bump page 57 to earlier (page 26 or page 27)
- Ryan suggests keeping all the detailed info in the back to not scare people off.
- Tricia suggests getting rid of table of contents and just do section headings (ex: Resources, safety, rules and expectations). With hyperlinks.
- Michelle: correct spelling of Danielle's name (p.6)

Michelle: p. 10: delete a in Melissa Ricci's name (middle of page)

Michelle: If your child has a specific allergy, please contact the school nurse.

Michelle: Put in a line letting people know that the cafeteria served lunches are always

nut free.

- Nan: Surprised by line on page 15 that info about placement info should be given to guidance counselors, not necessarily teacher.
- Tricia explained about the requesting and placement process
- Michelle: Questioned what "personnel matters" refer to
- Tricia explained that infrequently a parent has a question about a staff member
- Lise: So much of this is about selling the handbook and getting people to read it. Weaving skits into school assembly would be great.
